**Liability Release**

Furthermore, that there may be risks not known to all parties or not reasonably foreseeable at this time.

C) Assume all the foregoing risks and accept personal responsibility for the damages following such injury, permanent disability, or death.

D) Have obtained from each parent/guardian their agreement to release, waive, discharge, and covenant not to bring suit against any of the tournament administrators, directors, agents, coaches, employees, volunteers, and/or owners of the premises to be used to conduct the event, and release all of the aforementioned parties from any and all liability to each player, parent/guardian, heirs, and next of kin for any and all claims, demands, losses, or damages on account of injury, including death or damage to property, caused or alleged to have been caused in whole or in part by negligence of the aforementioned parties.
